- To provide the names and addresses of three customers for whom work has been carried in the last 12 months. These clients will be contacted by SARA for references.
- To provide copies of all printed material, as well as any other information that may assist the Membership Committee when considering your application;
- To provide evidence that you/your firm is adequately insured;
- To provide the brief details of the careers of all Directors or Partners of the firm;
- To be available for interview.
